The Regular Meeting of the Branchville Borough Council was held on Wednesday, April 6, 2022 at 7:00 p.m. at the Branchville Municipal Office, 34 Wantage Ave, Branchville, New Jersey.

Mayor Frato opened the meeting with the flag salute and the reading of the New Jersey Open Public Meetings Act Statement.

The New Jersey Open Public Meetings Act was enacted to ensure the right of the public to have advance notice of and to attend meetings of public bodies at which any business affecting their interest is discussed or acted upon. In accordance with the provisions of this Act, the Branchville Borough Council has caused notice of this meeting to be published by having the date, time and place thereof sent to the New Jersey Herald.

The roll was called. Those present were Mayor Frato, Council Members Bathgate, Bellis, Doremus, Orr, Van Stone, Whitesell. Councilwoman Bathgate, Councilman Doremus, Councilman Bellis and Mayor Frato stated positive remarks about Jeff Lewis and his 24 years of employment. No action taken. BOROUGH OF BRANCHVILLE SUSSEX COUNTY, NEW JERSEY ORDINANCE # 03-2022

CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Committee of the Borough of Branchville in the County of Sussex finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$35,707.70 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Borough Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Committee of the Borough of Branchville, in the County of Sussex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Borough of Branchville shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$35,707.70 and that the CY 2022 municipal budget for the Borough of Branchville be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

BOROUGH OF BRANCHVILLE

Ordinance #02-2022

An ordinance amending sections of the Code of Branchville including sections relating to: Parking of certain commercial vehicles; 123-23.3. and Parking; 116-8.1 No parking during snow removal and index of the code of the Borough of Branchville

BE IT ORDAINED by the Mayor and Council of the Borough of Branchville, in the County of Sussex, and the State of New Jersey that the following Sections of the Code of the Borough of Branchville are amended as follows:

Chapter 123. Zoning

Article VI. Supplemental Regulations

§ 123-23.3. commercial vehicles size - This section is revised to state as follows:

No commercial vehicle with six or more road wheels, weighing 27,000 lbs or more, shall be permitted to park between the hours of 8:00 p.m. and 7:00 a.m. on borough owned streets, in residential zone districts and residential areas. This prohibition includes, without limitation, trucks, tractor-trailers, and other commercial vehicles. In addition to all penalties and fines available against the vehicle owner under the Borough's Ordinances, any vehicle which is parked in violation of this section may be towed at the owner's expense.

Chapter 116. Vehicles and Traffic - The following new Section is added to this Chapter:

Article II. Parking

§ 116-8.1. No parking during snow removal.- Ice storm and towing

Whenever snow or ice has fallen and the accumulation is such that it covers the public streets, no vehicle shall be parked on the public streets in the Borough of Branchville from 10:00 p.m. to 6:00 a.m. The above parking prohibition shall remain in effect beyond that time period until the streets have been plowed sufficiently and until that parking will not interfere with the normal flow of traffic. In addition to all penalties and fines available against the vehicle owner under the Borough's Ordinances, any vehicle which is parked in violation of this section may be towed at the owner's expense.

AN ORDINANCE AMENDING SECTION 95 OF THE CODE OF THE BOROUGH OF BRANCHVILLE

BE IT ORDAINED by the Mayor and Council of the Borough of Branchville, in the County of Sussex, and State of New Jersey that the following Sections of the Code of the Borough of Branchville are amended as follows:

Chapter 95. Sewers

Section 95-4, "Application for Connection" is amended as follows:

a. <u>The following additional language is added to Subsection 95-4A of this</u> <u>Section</u>: Sewer connection permits will expire 52 weeks after the date of issue. Expired permits will be subject to renewals for a further period of 52 weeks each; however, a new application fee for each renewal must be paid based on the application fees in effect when each renewal application is received. Also, if a connection fee was paid with prior applications, the applicant must also pay, with each renewal application, the difference between the connection fee in effect when the renewal application is submitted and the total connection fee paid with the prior applications.

All other Sections in the Code of the Borough of Branchville shall remain in full force and effect.

Effective Date. This Ordinance shall become effective upon passage and publication as required by law.

BOROUGH OF BRANCHVILLE ORDINANCE NO. 05-2022

AN ORDINANCE AMENDING SECTION 119 OF THE CODE OF THE BOROUGH OF BRANCHVILLE

BE IT ORDAINED by the Mayor and Council of the Borough of Branchville, in the County of Sussex, and State of New Jersey that the following Sections of the Code of the Borough of Branchville are amended as follows:

Chapter 119. Sewers

Section 119-1, "Establishment of Water Rates" is amended as follows:

The following new subsection is added to Section 119-1, "Establishing of Water

Rates:

c. The approval issued by the Borough for connection to the Borough water supply will expire 52 weeks after the Borough's issuance of the approval letter. Expired approvals will be subject to renewal for a period of 52 weeks each; however, a new connection fee for each renewal must be paid based upon the connection fee in effect when each renewal request for water connection is received. If a connection fee was paid with prior requests for a connection, the applicant must also pay, with each renewal application, the difference between the connection fee in effect when the renewal request is submitted and the total connection fees paid with the prior requests.

All other Sections in the Code of the Borough of Branchville shall remain in full force and effect.

Effective Date. This Ordinance shall become effective upon passage and publication as required by law.

WHEREAS, the Borough of Branchville provides fire protection resources for ordinary emergency response requirements within its jurisdiction; and

WHEREAS the Fire Departments in Sussex County have a day-to-day responsibility to provide for the safety and security of lives and property; and

WHEREAS, local resources can become exhausted during the small percentage of large magnitude fire or disaster occurrences; and

WHEREAS, mutual aid is the most cost-effective method of providing sufficient resources to a local jurisdiction for those extraordinary occurrences including water emergency standby; and

WHEREAS, it is of mutual benefit for fire agencies located within the County of Sussex to provide supplemental resources to each other in the event of a local emergency or disaster; and

WHEREAS, the Sussex County Fire Coordinator is requesting a Per Diem Mutual Aid Agreement for Water Emergency Standbys will provide a uniform procedure for the coordination of the requesting, dispatching, and utilization of fire department personnel and equipment whenever a local fire agency requires mutual aid assistance from any other jurisdiction, both contiguous and non-contiguous, in the event of a fire or emergency; and

WHEREAS, it is the desire of the Governing Body of the Borough of Branchville to participate in the Sussex County Fire Coordinator Per Diem Mutual Aid Agreement for Water Emergency Standbys in accordance with the agreement as plan as submitted by the Sussex County Fire Coordinator.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of the Borough of Branchville, Sussex County, New Jersey, the Mayor and Borough Clerk are hereby authorized to execute the Per Diem Mutual Aid Agreement for Water Emergency Standbys on behalf of the Borough of Branchville.

BE IT FURTHER RESOLVED that a copy of this resolution be forwarded to the Sussex County Fire Coordinator.

WATER TENDER MUTUAL AID AGREEMENT

This agreement is for the response of fire service water tenders to a municipality for fire protection that is experiencing a water emergency.


If you are an agency that has a Fire Service Water Tender and would normally respond to these incidents you would need to first have your municipal officials pass a resolution authorizing you to do so. Exception - if you are not affiliated in any way with the municipality, self-insured and self-governed.

In this resolution you would need to have your municipality give the fire department officers the ability to sign the agreement on their behalf so as to not to delay the deployment. Also, in the resolution a statement needs to be included that any and all monies collected are to go directly into the fire department budget.

This document will utilize the FEMA fee schedules for apparatus and manpower so if for some reason there is a state of emergency and FEMA funds are available, these monies can be recouped by all parties.

RESOLUTION OF THE BOROUGH COUNCIL OF THE BOROUGH OF BRANCHVILLE

WHEREAS, the Borough Council of the Borough of Branchville has determined that certain space on the existing Borough water storage tank for approximately twelve (12) antennas and related materials, is not needed for public use and that a portion of the land abutting said water storage tank consisting of approximately 720 square feet is not necessary for public use; and

WHEREAS, the Borough Council has determined that an opportunity exists for the Borough to generate revenues by leasing the aforesaid space and land to the highest bidder;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Branchville:

- A. That the aforesaid space and land be and are hereby determined by the Council to be not needed for public use;
- B. That a lease for the aforesaid space and land be offered to private persons or entities following the submission of sealed bids wherein said lease shall be made to the highest bidder; however, the Council hereby reserves the right to reject all bids where the highest, complying bid is not accepted. Upon the completion of all bidding, the highest bid may be accepted, or all the bids may be rejected.
- C. That the Clerk of the Borough is directed to make such advertisement for the submission of sealed bids for the space to be leased in accordance with N.J.S.A. 40A:12-14. Said advertisement shall provide that the Borough reserves the right to reject all bids where the highest bid is not accepted, and that the tenancy shall be subject to the conditions, restrictions and limitations stated in the attached form of Lease which attached form is hereby approved by the Borough Council.
